## COVID-19 Spring 2021 Policies

The National Executive Board of Alpha Psi Lambda National, Inc. recognizes that the current environment is difficult to conduct Fraternity operations for many reasons, and makes it difficult for members and Associate members to connect and build relationships.

However, it is critical that our Chapters maintain practices that protect the safety and health of our Members, Associate Members and the broader campus community. All Members and Associate Members are expected to comply with the below policies for the Spring 2021 term.

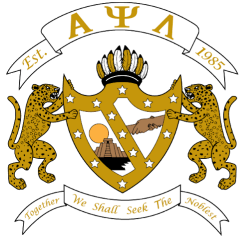
While there may be opportunities to conduct in-person meetings or activities (on/off campus), please recognize that if anyone feels uncomfortable it is encouraged for all activities to be conducted virtually, or for individuals to be provided the option to participate virtually.

Please note that University policies that further limit activities take precedence over these. For example, if a campus requires all activities be virtual, then all activities must be transitioned to a virtual platform.

## COVID-19 Spring 2021 Standard Policies

- Follow and respect all guidance from the University, local and state governments
- If anyone does not feel well, they should not attend any in-person activities (on/off campus)
- Practice social distancing at all possible times (on/off campus)
- All Individuals must wear face masks while indoors (on/off campus) during any Fraternity meetings, activities, programs
- All individuals must wear face masks when not social distancing (on/off campus)
- Touching is not allowed

- No shared food is to be provided (on/off campus)
- For indoor (on/off campus) Chapter meetings/Events/Community Service/Fundraising/ Membership Intake:
  - Groups of 10 or less may meet in person but must wear face masks and social distance. All other individuals must attend virtually
  - Groups larger than 10 must meet virtually (Exception: University Sponsored events that may have a larger maximum)
  - If any Members or Associate Members are uncomfortable meeting in person, a virtual option must be provided
  - If a National Officer is attending an event in person they count toward the number of 10 individuals
  - Meetings must not exceed 90 minutes in-person
- Tabling:
  - Limited to two members per table
  - Contact-free; Use technology such as QR codes, google forms, etc.
  - Electronic payments only, no cash handling
- No activities, icebreakers or teambuilders, may involve physical contact between attendees (on/off campus)
- In the event that a Member or Associate Member tests positive or is exposed to COVID-19:
  - All activities must be moved to a virtual platform until further notice
  - Contact your Regional Director immediately for further assistance/instruction.
